Do, Nhat-Dang. 2025. "From the Ballot and the Streets to Lobbies: Mapping Racial Minority Representation in Lobbying." Under Revise and Resubmit at *PS: Political Science*.

Abstract: Scholarship in Race, Ethnicity, and Politics (REP) has long focused on voting and protest, overlooking lobbying as a site of racial representation. This paper introduces a novel dataset of over 250,000 California bill analyses (1997–2018) to examine lobbying by racial minority interest groups (RMIGs). The data provides rare insight into when RMIGs are present in policymaking. Preliminary findings show that RMIGs are more influential when embedded in large, diverse coalitions. These results challenge the assumption that lobbying is reserved for elite actors and highlight coalition-based lobbying as a critical, underexamined mechanism of political incorporation for marginalized groups.

Do, Nhat-Dang. 2024. "Reliable Representatives: Racial Minority Interest Group (RMIG) Lobbying"

Abstract: Previous research has shown that the work of advocacy organizations representing marginalized communities is biased in ways that fail to represent the interests of the disadvantaged. Rather than being equal representatives of their group, these internal biases lead to disproportionately higher levels of attention to the privileged members within their groups. Are organizations specifically and explicitly representing racial groups also subject to such biases? I conceptualize these groups as a separate category of advocacy organizations called racial minority interest groups (RMIGs), whose purpose is to lobby on behalf of racial minorities. RMIGs' behavior differs from traditional lobbying or advocacy organizations because race is at the center of group goals and shapes resources. Using part of an original dataset of over 250,000 legislative bill analyses over twenty years, I show that RMIGs have actively lobbied across a diverse range of issues and are generally reliable representatives of their racial groups. They represent the interests of marginalized people more than the interests of the elites within their groups. Using structural topic modeling, I also show the lobbying proclivities of Latinx, Black, and Asian RMIGs. These findings suggest a more nuanced and optimistic view of racial minority representations in lobbying than previously considered.
